WHO QUALIFIES?

Homeowners in the City of Muskegon at or below 80% of Area Median Income (AMI) whose exterior siding is composed of wood, imitation brick, slate or chipboard, and has extensive damage. Aluminum or vinyl sided houses are not eligible.

HOW MUCH ASSISTANCE IS PROVIDED?

The full cost of labor and materials to replace approved existing façade with vinyl siding.

HOW IS ASSISTANCE PROVIDED?

A payment is made directly to the licensed contractor providing the service. A five-year non-diminishing lien will be placed against the property at project completion, after five years, the lien is forgiven.

APPLICANT MUST...

- Submit a complete application with fee due upon approval:
 0%-50% AMI \$60 51%-60% AMI \$250 60%-80% AMI \$500
- Have a household income at or below 80% area median income
- Be the owner occupant of the single-family dwelling, or have a recorded land contract, with written approval from the land contract holder
- Have property taxes current, own the home for at least a year, and have homeowner's insurance.
